The awards were based upon low bid per item and contained options to renew for two (2) additional twelve (12) month periods at the same prices.

Carolina Textiles elected not to renew. The remaining vendors notified Purchasing in writing that their prices will remain firm through November 17, 2018. The Sheriff's Department notified Purchasing in writing that they are pleased with the vendors listed above and want to renew.

Therefore, it is the joint recommendation of the Sheriff's Department and Purchasing that the Commissioners Court approve renewal of Bid No. 2016-190, Annual Contract for Inmate Hygiene Supplies, for another twelve (12) month period.

FISCAL IMPACT:

Expenses for last year were approximately \$135,139.01. Orders are placed on an as-needed basis.
