BACKGROUND:

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred eighty-two (182) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on February 27, 2019 was attended by eight (8) vendors as well as representatives from Transportation Services and Purchasing. Nine (9) bids were received.

Bids were evaluated by Transportation Services and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

No-bids were received for items 3B, 13A, 13B, 16D or 16E. There are no secondary awards for items 12D, 13C or 16F because only one bid was received for these items. There are no alternate awards for items 1B, 2C, 3A, 5A, 6B, 6D, 6F, 9E, 16A, 16C, 18D or 19A because only two bids were received for these items.

Tie bids were received for items 3C, 9C, 12B, and 19C. The award recommendations were determined in accordance with Commissioners Court Order No. 60616, Procedure for Awarding Tie Bids.

The term of the contract is twelve (12) months, effective May 22, 2019, with two (2) options for renewal periods of twelve (12) months each.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that Bid No. 2019-121, Annual Contract for Automotive and Light Truck Parts and Supplies, be awarded to the vendors listed above at the discount from list price.

FISCAL IMPACT:

Expenses for last year were approximately \$163,000.00. Orders are placed on an as-needed basis.
