BACKGROUND:

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred sixteen (216) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on February 8, 2018 was

attended by seven (7) vendors as well as representatives from Facilities Management and Purchasing. Six (6) bids and one (1) no bid were received.

Bids were evaluated by Facilities Management and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Therefore, it is the joint recommendation of Facilities Management and Purchasing that Bid No. 2018-054, Purchase of Furniture for Tarrant County Southwest Subcourthouse Expansion, be awarded to the vendors listed above at the per unit price.
