BACKGROUND:

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred twenty-six (126) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Five (5) bids were received.

Bids were evaluated by the four (4) Precincts and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

There are no secondary awards for Section 1 items 1, 2, 9, 19-22, and 32 because only no-bids were received for these items.

The term of the contract is twelve (12) months, effective August 7, 2018, with two (2) options for renewal periods of twelve (12) months each.

Therefore, it is the joint recommendation of the four (4) Precincts and Purchasing that Bid 2018-154, Annual Contract for Traffic Control Equipment, be awarded to the vendors listed above at the per unit price and discount from list price.

FISCAL IMPACT:

Expenses for last year were approximately \$17,220.00. Orders are placed on an as-needed basis.
