### **BACKGROUND:**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One thousand four hundred thirty-two (1,432) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. Forty-seven (47) proposals were received.

Proposals were evaluated by Information Technology and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP. The proposal received from Recruiting 3D, Inc., ProSoft Technology Group, Inc., ICON Information Consultants, LP, Object Information Services, Inc., Rose International, Inc., Global Infotech Services, LLC, and McIntosh Search, Inc. were deemed non-responsive for failure to include a signed Addendum as required.

The term of the contract is twelve (12) months, effective April 20, 2016, with one option for a renewal period of twelve (12) months.

Therefore, it is the joint recommendation of Information Technology and Purchasing that RFP No. 2016-048, Information Technology Staffing Augmentation Services, be awarded to the vendors listed above at the per unit price.

### **FISCAL IMPACT:**

Expenses for last year were approximately \$1,437,200.00. Services are provided on an as-needed basis.
