SUBJECT: RFP NO. 2017-086 - OUT-PATIENT TREATMENT SERVICES FOR JUVENILES WITH SEXUAL BEHAVIOR PROBLEMS - JUVENILE SERVICES - VARIOUS VENDORS - \$60,000.00

COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court award RFP No. 2017-086, Out-Patient Treatment Services for Juveniles with Sexual Behavior Problems, for Juvenile Services, to the following vendors for \$60,000.00 and approve contract:

BACKGROUND:

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred seventy-eight (278) vendors were contacted and requested to participate in this RFP process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. Two (2) proposals were received.

Proposals were evaluated by Juvenile Services and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP. Recommendations were presented to the Tarrant County Juvenile Services Board on May 17, 2017 and approved.

The contract is effective from June 1, 2017 through September 30, 2017 with three (3) options for renewal periods of twelve (12) months each.

The contract is attached for approval and signature. The Criminal District Attorney's Office reviewed this contract as to form.

Therefore, it is the joint recommendation of Juvenile Services and Purchasing that RFP No. 2017-086, Out-Patient Treatment Services for Juveniles with Sexual Behavior Problems, be awarded to the vendors listed above for \$60,000.00.
