COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court approve Amendment No. 4 to the Fiscal Year 2020-2021 Texas Department of State Health Services (DSHS) Ryan White Treatment Extension Act Part B subrecipient contract with Tarrant County Hospital District.

BACKGROUND:

On February 25, 2020, the Commissioners Court, through Court Order #132227, approved Amendment No. 4 to the DSHS FY 2020-2021 Ryan White Treatment Extension Act Part B HIV Services grant contract renewal totaling \$1,801,583.00.

On March 24, 2020, the Commissioners Court, through Court Order #132447, approved the FY 2020-2021 DSHS Ryan White Treatment Extension Act Part B subrecipient contract renewals with AIDS Healthcare Foundation and Tarrant County Hospital District.

On March 30, 2021, the Commissioners Court, through Court Order #135058, approved Amendment No. 3 to the FY 2020-2021 DSHS Ryan White Treatment Extension Act Part B subrecipient contract with Tarrant County Hospital District.

The term of these community subrecipient contracts is April 1, 2020 through March 31, 2021.
