The awards were based upon evaluation criteria set forth in the RFP specifications and contained options to renew for three (3) additional twelve (12) month periods.

The Center for Psychological Services elected not to renew. Substance Abuse Guidance and Education (SAGE) did not respond to renewal request. The remaining vendors notified Purchasing in writing that they will extend the same contract terms through April 30, 2022. CSCD notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of CSCD and Purchasing that the Commissioners Court approve renewal of RFP No. 2017-106, Offender/Defendant-Paid DWI Education, DWI Repeat Offender Program, and Drug Offender Education Program, for another twelve (12) month period.
