#### **PROGRAM STATUS**

The County is continuing the administration of **COVID-19 Vaccinations.** There are currently 8 public health partnership vaccination sites for which weekly vaccination doses are reported in Tarrant County. 11 TCPH partner sites are scheduled as noted below.

The County has **2 COVID-19 Testing Sites** operated by TDEM in partnerships with the City of North Richland Hills, and the City of Fort Worth and TCC-South.

The **Emergency Rental Assistance Program** (ERAP) opened on March 29<sup>th</sup> applications are being processed and paid on a rolling basis. All Eviction Diversion referrals are being routed to ERAP.
