COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court approve Amendment No. 3 to the Fiscal Year 2021-2022 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A subrecipient contract with AIDS Outreach Center.

BACKGROUND:

On March 2, 2021, the Commissioners Court, through Court Order #134895, approved the receipt of the HRSA FY 2021-2022 Notice of Award for the Ryan White Part A grant contract in the amount of \$1,079,630.00

On April 13, 2021, the Commissioners Court, through the Court Order #135199, approved Amendment No. 1 to the Fiscal Year 2021-2022 HRSA Ryan White Part A Final Notice of Award in the amount of \$3,760,377.00. With this amendment, the Ryan White Part A funding is \$4,840,007.00.

On April 13, 2021, the Commissioners Court, through Court Order #135197, approved the receipt of the Fiscal Year 2021-2022 HRSA contract renewal with AIDS Outreach Center.

On May 18, 2021, the Commissioners Court, through Court Order #135470, approved Amendment No. 1 to the Fiscal Year 2021-2022 HRSA Ryan White Treatment Extension Act Part A contract with AIDS Outreach Center.

On June 1, 2021, the Commissioners Court, through Court Order #135563, approved Amendment No. 2 to the Fiscal Year 2021-2022 HRSA Ryan White Treatment Extension Act Part A contract with AIDS Outreach Center.

As part of Tarrant County's responsibility as the administrative agency for this grant, a network of subrecipients is maintained to support treatment and care for HIV-positive individuals in the Fort Worth Transitional Grant Area. AIDS Outreach Center is a participating subrecipient.
